A. INTRODUCTION

- I am employed by Tabcorp Holdings Limited ACN 063 780 709 (Tabcorp) as General Manager Secretariat and Shareholder Relations. I am authorised to make this statement on Tabcorp's behalf.
- 2. Exhibited to me at the time of signing this statement and marked "Exhibit MWS-1" is a bundle of documents. Where in this statement I refer to documents, I refer to them by reference to their tab number in MWS-1 and their unique document number beginning with a "TBP" prefix. I have reviewed the documents to which I refer prior to signing this statement.
- 3. The matters set out in this statement are based on my knowledge of Tabcorp's operations and my involvement with Tabcorp's business as General Manager Secretariat and Shareholder Relations. I have also made enquiries of relevant staff and records of Tabcorp and its subsidiaries.

A.1. Experience and employment history

- 4. I have been employed by Tabcorp in the role of General Manager Secretariat and Shareholder Relations and similar roles since 23 September 2002.
- 5. Prior to joining Tabcorp, I was employed in the Corporate Affairs team at the Office of Gas and Electricity Markets in London, United Kingdom, a position I held from 2000 to 2002. Prior to that role, I was a Corporate Communications Manager at Ashton Mining from 1994 to 2000.
- 6. I hold a Bachelor of Land Information in Cartography, Geographic Information
 Science and Cartography from RMIT University and a Graduate Diploma in Applied
 Corporate Governance.

B. TABCORP COMPANY INFORMATION REQUIRED FOR THE FORM S

7. I have been asked to provide certain information which I am informed by Tabcorp's solicitors, Herbert Smith Freehills, is required for the Form S. That information is set out in sections B.1 to B.3 below and in Exhibit MWS-1 and is current as at 28 September 2017.

B.1. Corporate and ownership details

Tabcorp is incorporated in Victoria and its registered address is Level 21, Tower 2,
 727 Collins Street, Victoria 3008.

- 9. Tabcorp is listed on the Australian Securities Exchange (**ASX**). As at 28 September 2017, Tabcorp has on issue:
 - (a) **Ordinary Shares:** 835,267,014 fully paid ordinary shares which are listed on the ASX under the code TAH; and
 - (b) **Performance Rights:** 2,564,136 Performance Rights issued to Tabcorp's senior employees pursuant to long-term incentive arrangements.
- All Ordinary Shares issued by Tabcorp carry one vote per share. Performance Rights
 do not carry any right to vote.
- 11. A copy of Tabcorp's Constitution is at **Tab 1** of **MWS-1** [**TBP.004.013.5037**]. Tabcorp's Constitution, together with an agreement entered into with the State of Queensland, contain restrictions prohibiting an individual from having a voting power of more than 10%. Tabcorp may refuse to register any transfer of shares which would contravene these shareholding restrictions or require divestiture of the shares that cause an individual to exceed the shareholding restrictions.
- 12. A copy of Tabcorp's Annual Report for the year ended 30 June 2017 (FY2017 Annual Report) is at Tab 2 of MWS-1 [TBP.020.001.0001].
- 13. As at 28 September 2017, Tabcorp's register of members identified the following shareholders as having a greater than 5% shareholding:
