THE TRIBUNAL DIRECTS BY CONSENT THAT:

Definitions used in these directions

1. The following defined terms apply for the purposes of these directions:
 - a) **Additional Documents** means the documents listed at Annexure 1 of these directions, which the Australian Competition and Consumer Commission (**Commission**) has agreed should be added to the Documentary Index.
 - b) **Confidentiality Regime** means the confidentiality regime annexed to the directions of the Tribunal made in this proceeding on 21 July 2026.
 - c) **Documentary Index** means the documentary index filed and served by the ACCC on 28 July 2026 pursuant to paragraph 11 of the directions of the Tribunal made in this proceeding on 21 July 2026.

3. By 14 August 2026, the ACCC is to file and serve an updated Documentary Index containing the Additional Documents and Further Documents.
4. By 14 August 2026, the ACCC is to serve on each participant an electronic bundle of the Additional Documents and the Further Documents where no confidentiality claimant other than the Applicant is identified.
5. The Confidentiality Regime and directions 5 to 10, 13 and 14 made by the Tribunal in this proceeding on 21 July 2026 will apply to the Further Documents and the Additional Documents, with the following amendments to the dates in the directions dated 21 July 2026 in respect of the Further Documents and the documents with document IDs 01068.022.041.0178, 01068.022.030.0051, 01068.022.042.0001, 01068.022.042.0002 and 01068.022.042.0003:
 - a. the date in para 8 of the directions dated 21 July 2026 by which the Commission is to notify a non-participant who provided any of the documents be amended to 14 August 2026;
 - b. the date in paras 8(b) and 9 of the directions dated 21 July 2026 by which a non-participant or participant may apply to the Tribunal for further directions in respect of any of the documents be amended to 19 August 2026; and
 - c. the date in para 13 of the directions dated 21 July 2026 by which the Commission is to serve an electronic bundle containing the documents that are not subject to an application for further directions be amended to 20 August 2026.
