## THE TRIBUNAL DIRECTS THAT:

## Evidence

- The Applicant is to file and serve any proposed evidence on or before Tuesday 21 April 2020.
- 17. The Authorisation Applicants are to file and serve any proposed evidence on or before Tuesday 5 May 2020.
- Each intervener is to file and serve any proposed evidence on or before Tuesday 5 May 2020.
- The Commission is to file and serve any proposed evidence on or before Tuesday 12 May 2020.
- 20. The Applicant is to file and serve any proposed evidence in reply on or before Tuesday 19 May 2020.

- 21. The Authorisation Applicants are to file and serve any proposed evidence in reply on or before Tuesday 19 May 2020.
- 22. The Applicant is to serve a draft Hearing Book Index listing all documents proposed to be relied upon at the hearing on or before Friday 22 May 2020.
- The Authorisation Applicants and any intervener are to serve a list of proposed amendments to the Hearing Book Index on or before Tuesday 26 May 2020.
- The Commission is to serve any proposed amendment to the Hearing Book Index on or before Friday 29 May 2020.
- 25. The Applicant must file and serve the Hearing Book (including its contents) on or before Tuesday 2 June 2020.
- 26. On or before Friday 22 May 2020, the parties and the Commission file an agreed document which identifies:
  - a. any witnesses to be cross-examined; and
  - b. any objection to evidence, with objections being identified with precision.

#### Submissions and authorities

- 27. On or before Friday 22 May 2020, the Applicant is to file and serve an outline of submissions with a list of authorities.
- 28. On or before Friday 29 May 2020, the Authorisation Applicants are to file and serve an outline of submissions with a list of authorities.
- 29. On or before Friday 29 May 2020, any intervener is to file and serve outlines of submissions with a list of authorities.
- 30. On or before Friday 5 June 2020, the Commission is to file and serve any outline of submissions with any list of authorities.
- b. Subject to further directions, the Hearing Book to be filed with the Tribunal is to be in electronic form, which:
  - i. is produced in a text-recognised PDF format;
  - ii. is paginated sequentially throughout;
  - iii. is divided into volumes such that each volume is a PDF file and the file name of each PDF file is the volume number; and

- iv. each PDF file contains electronic bookmarks to each document in that file.
- c. The proceeding is listed for hearing in Melbourne commencing on Tuesday 9 June 2020 with an estimate of 3 to 4 hearing days.
