APPLICATION BY WOOLWORTHS GROUP LIMITED FOR FURTHER DIRECTIONS

Woolworths Group Limited (**Woolworths**), a Third Party (as defined in the Confidentiality Regime annexed to the Tribunal's directions dated 21 July 2026 (**Confidentiality Regime**)) which produced Confidential Information (as defined in the Confidentiality Regime) to the Australian Competition and Consumer Commission (**ACCC**) in connection with Coles Supermarkets Australia Pty Ltd's (**Coles**) proposed acquisition of a leasehold interest, seeks the following further directions pursuant to paragraph 8(b) of the Tribunal's directions dated 21 July 2026 (the **Directions**):

1. Internal lawyers employed by any Participant (as defined in the Directions) are not to have access to parts of the documents listed in Annexure A of these directions, being those parts identified as Highly Confidential Information in Confidential Exhibit BJW-1.
2. Internal lawyers employed by any Participant are not to have access to the whole of the documents listed in Annexure B of these directions and described as Highly Confidential Information in Confidential Exhibit BJW-1.
3. The documents in Annexures A and B of these directions are otherwise subject to the Confidentiality Regime and can be accessed by persons referred to and in accordance with that regime.
4. The file name of the document provided by Woolworths to the ACCC with Document ID [WOW.002.002.0004] be redacted from any publication of that file name (including indexes) so as to not disclose the words that appear in the brackets, including the store name.
5. The Attachment to Confidentiality Regime: Confidentiality Undertaking, be amended so as to include a new paragraph 3A beneath paragraph 3 which states:

3A I will keep the Highly Confidential Information (as referred to in the Tribunal's directions dated [insert]) confidential and will not disclose the Highly Confidential Information directly or indirectly to any person, other than persons who have signed this undertaking and who are permitted to access Highly Confidential Information pursuant to the directions of the Tribunal in the proceedings related to confidentiality. I also will not receive any Confidential Information directly or indirectly from a person if a direction has been made by the Tribunal precluding such receipt and I am aware (or ought reasonably to be aware) that the information being disclosed is subject to that direction.
