On 29 September 2017, I, ANNE TUCKER of 87 Ipswich Road, Woolloongabba, Queensland, General Counsel and Company Secretary, say:

- 1. I am the General Counsel and Company Secretary of Tatts Group Limited, ACN 108 686 040 (Tatts).
- This statement is made in support of an application by Tabcorp Holdings Limited
 (Tabcorp) to the Australian Competition Tribunal (the Tribunal) for authorisation of
 the merger of Tatts and Tabcorp.
- 3. Exhibited to me at the time of making this statement and marked "Exhibit AT-1" is a bundle of the documents. Exhibited to me at the time of making this statement is a further bundle of documents marked "Confidential Exhibit AT-2". Tatts claims confidentiality over Confidential Exhibit AT-2.
- 4. Where in this statement I refer to documents, I refer to them by reference to their unique document number beginning with a "TAT" prefix. I have reviewed those documents prior to signing this statement.
- Set out in this statement are matters based on my knowledge and experience as General Counsel and Company Secretary of Tatts. I have also made enquiries of relevant Tatts' books and records.

A. EXPERIENCE AND EMPLOYMENT HISTORY

- 6. Since July 2013, I have been employed as General Counsel and Company Secretary for Tatts.
- 7. Prior to this appointment, I was employed as a Solicitor at Clayton Utz between 2000 and 2002, and as a Legal and Compliance Counsel at UNiTAB from June 2005 until its merger with Tatts in 2006, and as a Senior Corporate Solicitor with Tatts from October 2006 where I continued in that role until 2013.
- 8. I hold a Bachelor of Laws with Honours and a Bachelor of Commerce granted by the University of Queensland. I am also an associate of the Governance Institute of Australia.

B. OVERVIEW OF TATTS

Tatts is incorporated in Victoria.

I collated the information contained in Tab 1 of Exhibit AT-2 [TAT.001.045.0084] together with Mr Andrew Collins, Head of Mergers & Acquisitions (the wagering, lotteries, keno and gaming information), Ms Sue van der Merwe, Chief Operating Officer Lotteries (lotteries and keno information) and Mr Frank Makryllos Chief Operating Officer Gaming (gaming information only). Each of these individuals is an employee of Tatts. I am informed by these individuals and believe that the information contained in Tab 1 of Exhibit AT-2 [TAT.001.045.0084] is correct.

Wagering

- 17. I have been asked to provide Tatts' actual average take out rates from FY13 FY17 in relation to Tatts' totalisator wagering business. A table setting out this information is in Tab 1 of Exhibit AT-2 [TAT.001.045.0084] at .0085.
- 18. I have been asked to provide information on Tatts' UBET+ loyalty/rewards program structure for FY17. A table setting out this information is at **Tab 1** of **Exhibit AT-2** ITAT.001.045.00841 at .0161.
- 19. I have been asked to provide information on the inputs into the production of goods or services by Tatts' wagering business in FY17, including the supplier/s, substitutes (if any), total spend in FY17, and total spend on input/s as a proportion of total costs incurred by Tatts' wagering business in FY17. A table setting out this information is at Tab 1 of Exhibit AT-2 [TAT.001.045.0084] at .0089.
- 20. I have been asked to provide the names and contact details of a representative selection of suppliers of inputs to Tatts' wagering business. I have also been asked to provide data as to the relative proportion of Tatts' supply costs in its wagering business accounted for by statutory outgoings, employee costs, operating fees and direct costs, telecommunications and technology, marketing and promotions, information services, property expenses and other costs. I have been asked to provide Tatts' estimate of the number of electronic gaming machines provided with Tatts' gaming systems and related services, field services and monitoring services for FY13-FY17 by State. A table setting out this information is in **Tab 1** of **Exhibit AT-2** [TAT.001.045.0084] at .0147.
- I have been asked to provide information on the inputs into the production of goods or services by Tatts' gaming services business in FY17, including the supplier/s, substitutes (if any), total spend in FY17, and total spend on input/s as a proportion of total costs incurred by Tatts' wagering business in FY17. A table setting out this information is at Tab 1 of Exhibit AT-2 [TAT.001.045.0084] at .0095.
- 24. I have been asked to provide names and contact details of a representative selection of suppliers of input to Tatts' gaming services business. A table setting out this information is at **Tab 1** of **Exhibit AT-2** [TAT.001.045.0084] at .0111.
- I have been asked to provide information on Tatts' gaming services customers and customer agreements, particularly contact details, customer size, the goods and/or services purchased, the value of those goods and/or services purchased, the number of electronic gaming machines served, and current and post-transaction supply arrangements with the customers. I have been asked to provide Tatts' gaming systems and related services, field services and monitoring services revenue and volume (number of electronic gaming machines serviced) for the last 5 financial years. - 27. I have been asked to provide Tatts' gaming services business market share by revenue and volume (number of electronic gaming machines serviced). A table setting out this information is at **Tab 1** of **Exhibit AT-2** [TAT.001.045.0084] at .0147.

Keno

28. I have been asked to provide information on the inputs into the production of goods or services by Tatts' keno business in FY17, including the supplier/s, substitutes (if any), total spend in FY17, and total spend on input/s as a proportion of total costs incurred

- by Tatts' keno business in FY17. A table setting out this information is at **Tab 1** of **Exhibit AT-2** [TAT.001.045.0084] at .0101.
- I have been asked to provide the names and contact details of a representative selection of suppliers of inputs to Tatts' keno business, including the supplier size (small, medium or large), the goods and services supplied and the value and location of supply. I have also been asked to provide data on the relative proportion of Tatts' supply costs in its keno business accounted for by outlet commission, advertising, media and production costs, telecommunication costs, market research costs, freight costs, prize cheques costs, terminal consumables costs, employee costs, machine maintenance costs, shopfit costs, property expenses, company vehicle operating costs, business-related interstate and overseas travel expenses, insurance, and postage. - 30. I have been asked to provide Tatts' keno revenue and turnover for the last 5 financial years. A table setting out this information is at **Tab 1** of **Exhibit AT-2**[TAT.001.045.0084] at .0159.
- 31. I have been asked to provide Tatts' keno business market share of the South Australian keno market, calculated by turnover. A table setting out this information is at Tab 1 of Exhibit AT-2 [TAT.001.045.0084] at .0159.

Lotteries

- 32. Each State and Territory imposes a legislated minimum percentage of the entry fee which must be distributed back to players as prizes (Minimum Return to Player Percentages). A table setting out Minimum Return to Player Percentages in each jurisdiction in which Tatts operates, as well as the actual return to player percentages offered by Tatts in FY17 is in Tab 1 of Exhibit AT-2 [TAT.001.045.0084] at .0087.
- 33. I have been asked to provide information on the inputs into the production of goods or services by Tatts' lotteries business in FY17, including the supplier/s, substitutes (if any), total spend in FY17, and total spend on input/s as a proportion of total costs incurred by Tatts' lotteries business in FY17. A table setting out this information is at Tab 1 of Exhibit AT-2 [TAT.001.045.0084] at .0097.
- 34. I have been asked to provide the names and contact details of a representative selection of suppliers of inputs to Tatts' lotteries business and data as to the relative proportion of Tatts' supply costs in its keno business accounted for by lottery licence fees in states/territories where Tatts holds the licence/s, Lottery taxes paid to Government in states/territories where Tatts holds the licence/s, outlet commission, advertising, media and production costs, telecommunication costs, instant tickets

production costs, market research costs, freight costs, prize cheques costs, terminal consumables costs, draw lottery/bloc administration costs, employee costs, machine maintenance costs, Goods and Services Tax, shopfit costs, property expenses, company vehicle operating costs, business-related interstate and overseas travel expenses, insurance, postage, and credit card merchant fees. A table setting out this information is at **Tab 1** of **Exhibit AT-2** [TAT.001.045.0084] at .0166.

- 35. I have been asked to provide Tatts' lotteries revenue and turnover for the last 5 financial years. A table setting out this information is at **Tab 1** of **Exhibit AT-2** [TAT.001.045.0084] at .0155, noting that Australian Gambling Statistics official published data on Australian lotteries market turnover data is not yet available for FY16 or FY17.
- 36. I have been asked to provide Tatts' lotteries business market share per jurisdiction by turnover. A table setting out this information is at **Tab 1** of **Exhibit AT-2**[TAT.001.045.0084] at .0157.

Cooperative agreements

37. I have been asked to describe any cooperative agreements to which Tatts is a party in the wagering, gaming, lotteries and keno markets.
