Evidence

- 1. Directions 17 and 18 of the Tribunal's directions made on 25 November 2020 be vacated.
- Port of Newcastle Operations Pty Limited (PNO) and New South Wales Minerals Council (NSWMC) are each to file and serve any further proposed evidence on or before 25 June 2021.
- 3. PNO, NSWMC and the Australian Competition and Consumer Commission (ACCC) are each to file and serve any proposed evidence in reply on or before 30 July 2021.
- 4. On or before 12 September 2021, PNO and NSWMC are to file an agreed document which identifies:
 - (a) any witnesses to be cross-examined; and
 - (b) any objection to evidence, with objections being identified with precision.

Hearing Book

5. PNO is to serve a draft index for the Hearing Book listing all documents proposed to be relied upon at the hearing on or before 30 July 2021.

- 6. NSWMC is to serve a list of any additional documents to be included in the Hearing Book on or before 6 August 2021.
- 7. The ACCC is to serve a list of any additional documents to be included in the Hearing Book on or before 13 August 2021.
- 8. PNO is to file and serve a Hearing Book containing the documents referred to in directions 5, 6 and 7 by 4.00pm on 20 August 2021 which is in electronic form and:
 - (a) is produced in a text-recognised PDF format;
 - (b) is paginated sequentially throughout;
 - (c) is divided into folders such that each folder comprises a single PDF file and the file name of each PDF file is the folder number; and
 - (d) each folder (being a PDF file) contains electronic bookmarks to each document in that folder.

- 9. PNO is to file and serve an outline of submissions and list of authorities not exceeding 20 pages by 4.00pm on 27 August 2021.
- 10. NSWMC is to file and serve an outline of submissions and list of authorities not exceeding 20 pages by 4.00pm on 17 September 2021.
- 11. The ACCC is to file and serve an outline of submissions and list of authorities not exceeding 20 pages by 4.00pm on 24 September 2021.
- 12. PNO is to file and serve an outline of submissions in reply not exceeding 10 pages by 4.00pm on 1 October 2021.

Hearing

13. The proceeding be set down for hearing in Sydney at 10.15am on 11 October 2021 for 5 days.
